DISBURSEMENT MODALITY REGARDING THE UONGOZI
INSTITUTE AND UNU-WIDER COOPERATION**

REF: Agreement amendment in order to revise a disbursement modality regarding the UONGOZI Institute and UNU-WIDER cooperation

With reference to the Agreement on support to the UONGOZI Institute signed between the Government of the Republic of Finland (Finland) and the Government of the United Republic of Tanzania (Tanzania), the Embassy of Finland and the UONGOZI Institute have noticed that the agreed disbursement modality regarding the research cooperation with the WIDER Institute is not the most suitable one. After having analyzed different options together with the UONGOZI Institute we therefore propose that the funds would be channeled from the Ministry for Foreign Affairs of Finland directly to the WIDER Institute. We therefore propose that the Agreement will be amended accordingly.

Consequently I have, on behalf of Finland, been authorized to enter into an Agreement with Tanzania, through an exchange of letters to amend the Agreement between Finland and Tanzania on the Co-operation in the UONGOZI Institute, signed on 29th November 2017.

I suggest that Article VI paragraph 2 regarding Disbursements of the above-mentioned Agreement shall be amended as follows:

1. Finland shall make payments for the earmarked funding of Aalto University leadership training against a written request by the UONGOZI Institute into the Institute's bank account annually. Finland shall make payments for research cooperation with WIDER Institute directly to WIDER Institute.
2. In all other respects the terms and conditions of the above-mentioned Agreement shall remain in force and in full effect.

If the foregoing is acceptable to Your Government, I have the honour to propose that this letter and Your written reply concurring herewith constitute an Agreement on Amendment no 1 to the above-mentioned Agreement between the Government of the Republic of Finland and the Government of the United Republic of Tanzania. I suggest that this Agreement shall enter into force 21 days after receipt of Your written reply concurring herewith.

I avail myself of this opportunity to present Sir, the renewed assurance of my highest consideration.
